

Since its inception in 1989, the Foundation's assets have grown to more than \$120 million in 278 endowment funds. Grants from these funds in 2014 exceeded \$10 million for nonprofit organizations and worthy causes including scholarships, bringing the Foundation's 25year cumulative distributions to \$60.1 million.

As a community foundation, Permian Basin Area Foundation strives to serve a multitude of donors from all walks of life at various economic levels and with widely-diverse charitable interests. 2014 GRANTS AND SCHOLARSHIPS

Permian Basin Area Foundation supports a broad range of programs and educational opportunities to improve the quality of life for West Texans. In 2014, the Foundation and its donors invested over \$10 million in local communities through grants to nonprofits and scholarships to students. These grants were made possible through recommendations of donors (donor-advised funds) and allocations from designated and undesignated funds including the Foundation's semi-annual competitive grants process.



Today, more than 80 Foundation scholarship funds help ensure that deserving young men and women have the resources necessary to pursue their academic goals. At its 18th Annual Scholarship Dinner in July 2014, the Foundation announced scholarship awards totaling \$429,232 for the upcoming 2014–2015 academic year.
