



2015 GRANTS & SCHOLARSHIPS

In 2015, the Permian Basin Area Foundation and its donors invested over \$10.8 million in local communities through grants to nonprofits and scholarships to students. The funds support a wide range of programs and educational opportunities to improve the quality of life for West Texans. Grants were made possible through donor recommendations (donor-advised funds) and allocations from designated and undesignated funds, including the Foundation's semi-annual competitive grants process. Sixty-six nonprofits, representing a broad spectrum of services, received \$2,063,204 in competitive grants funding.


